



## IPONZ v5 API Data Dictionary – Trade Mark Search Operation

This document provides additional information for the request and response data fields used in the IPONZ v5 API POST / TradeMarkSearch operation.

For convenience the following data dictionary of request and response content is a flattened version of the XML structure.

### POST /trademarksearch request

Field	Optional/ required	Description
<b>ClientRef</b> <i>String</i>	Optional	An identifier for the transaction. Included without modification in the response.
<b>Title</b> <i>String (255)</i> <i>Case insensitive</i>	Optional	Used for searching the trade mark title. Complex searches can be constructed through the use of *, ?, brackets, quotation marks, and boolean operators AND, OR, and NOT.  For detailed guide on searching criteria see: <a href="http://www.iponz.govt.nz/about-ip/trade-marks/search/">www.iponz.govt.nz/about-ip/trade-marks/search/</a>  e.g. <i>technolog*</i> Searches for any trade mark with words such as technology, technologies, technological etc. in the title.  <i>batman or robin</i> Searches for trade marks the words batman or robin in the title.
<b>FilingDateRange</b> FromDate, ToDate <i>Date</i>	Optional	Filter results to trade marks filed within the specified date range, format YYYY-MM-DD.  e.g. FromDate: 2022-01-30  ToDate: 2022-09-30

<b>RegisterDateRange</b> FromDate, ToDate <i>Date</i>	Optional	Filter results to trade marks filed within the registered date range, format YYYY-MM-DD.  e.g. FromDate: 2022-01-30  ToDate: 2022-09-30
<b>StatusList</b> <i>Array</i>	Optional	Filter results to trade marks with any of the specified StatusID's.
<b>StatusID</b> <i>Integer</i>	Required if StatusList is in request	A single status ID, see table further below for a list of all status IDs and their meaning.
<b>NatureItem</b> <i>Enumeration</i> Individual Collective Certificate	Optional	Filter results to trade marks with a particular nature.  Individual A standard trade mark, the function of this is to distinguish the goods or services that originate from a single party.  Collective A collective mark is a sign used, or intended to be used, in relation to goods produced or services provided in the course of trade by members of an association to distinguish those goods produced or services provided by persons who are not members of the association.  Certificate A certification mark is a sign certifying that the goods or services in respect of which it is used are of a particular origin, material, mode of manufacture, quality, accuracy, performance, or other characteristic.
<b>ApplicationTypeItem</b> <i>Enumeration</i>	Optional	Filter results to trade marks of a particular type, selected from: <ul style="list-style-type: none"><li>• Word</li><li>• Figurative</li><li>• 3-D</li><li>• Colour</li></ul>

<b>OwnerCustomerID</b> <i>String</i>	Optional	Filter results to trade marks where the owner/applicant has the specified IPONZ client ID.
<b>AgentCustomerID</b> <i>String</i>	Optional	Filter results to trade marks where the agent has the specified IPONZ client ID.
<b>GetGoodsAndServices</b> <i>Boolean</i>	Optional	Set to true if the response should include full details of the goods and services for each trade mark in the returned results.

## Response Data Dictionary

Field	Description
<b>ClientRef</b> <i>String</i>	The value of ClientRef sent in the request.
<b>ListTradeMarksIdentifier</b> <i>Token (String)</i>	A system identifier for the transaction that can be used to assist MBIE support if problems occur.
<b>ApplicationNumber</b> <i>PositiveInteger</i>	The trade mark number.
<b>MarkTitle</b> <i>String</i>	The trade mark title.
<b>MarkImageName</b> <i>String</i>	A reference that can be used to get an image or device file for the trade mark. Use this identifier in the ObjectIdentifier field of the download document operation to retrieve the file.
<b>MarkCurrentStatusCode</b> <i>String</i>	The trade mark status. See the table further below for status code details.



Field	Description
<b>FilingDate</b> <i>Date</i>	The date the trade mark was filed.
<b>GoodsAndServices</b> <i>nil or GoodsServicesType</i>	Contains the full details of the goods and services if <b>GetGoodsAndServices</b> was set to <b>true</b> in the request.
<b>ClassificationKindCode</b>	Not used.
<b>ClassificationVersion</b> <i>String</i>	The edition of Nice classification applicable to the trade mark's goods and services.  More information: <a href="http://www.wipo.int/classifications/nice/en/classifications.html">http://www.wipo.int/classifications/nice/en/classifications.html</a>
<b>ClassNumber</b> <i>NonNegativeInteger</i>	The Nice class for the specified goods and services.
<b>GoodsServicesDescription</b> <i>String</i>	The text description of the trade mark's goods and services in this class.
<b>ListTradeMarksErrorCode</b> <i>Token (String)</i>	<b>Application Error</b> Generally for errors with the input data or trade mark data.  <b>Fault Error</b> Errors with the web service itself.
<b>ListTradeMarksErrorText</b> <i>String</i>	Description of the specific error.
